Study to be conduct at Dr. Mary Jackson School

Northland School Division is going to be conducting a viability review on Dr. Mary Jackson School in accordance with Policy 15 – School Closure https://nsd61.ca/download/101463. The school in Keg River has 11 full time registered students. The study is going to involve conversations with parents, community members and school staff to pin point the reasons why enrolment is down.

Board Chair Report

In this edition of the Board Chair Report, Maddy Daniels briefly spoke about attending the Public School Boards Association of Alberta's Annual General Meeting and the Alberta School Boards Association (ASBA) Fall General Meeting (FGM) in November. Daniels attended the ASBA Awards Banquet to celebrate two awards connected to NSD. Chelsea Cattroll, Peerless School Teacher, received recognition for winning the Edwin Parr Teacher Award for Zone 1, which is for exceptional first year teachers. Our friends APPLE Schools received the provincial Friends of Education Award for significant contributions to education in Alberta. NSD nominated NSD for the award.

Student attendance highlighted in Superintendent's Report

The Superintendent's Report included good news with respect to student attendance. NSD achieved its best attendance result over the last 4 years in October. When comparing October 2016 to 2017, 11% more students achieved attendance rates between 95% - 100%. To ensure student attendance improvement continues, Superintendent of Schools Gord Atkinson says the division's Attendance Improvement Initiative "Every Day Counts" will focus on understanding why chronically absent students (below 70%) are not attending school. He says medical is one reason why students are not attending school.

Atkinson attended the ASBA FGM with the Board of Trustees November 19-22 in Edmonton. He accompanied the Board Chair and staff to congratulate Chelsea and APPLE Schools.
