Superintendent's Report presented to Board of Trustees



While presenting the Superintendent's Report on October 26, 2017, Gord Atkinson, Superintendent of Schools, informed the Board of Trustees that over 170 students are attending WE Day in Calgary. WE Day is an opportunity for students to celebrate personal accomplishments, listen and learn from inspirational people and receive more motivation to improve their community and the world. The report highlights meetings Atkinson attended in

September and October. On September 15th, he met with Edmonton Public Schools to discuss professional development and mentoring opportunities for NSD educators. During the principal's meetings September 11-13 in Edmonton, Atkinson shared information about classroom improvement funding. Following the discussion, principals toured 21ST century learning spaces in the Edmonton area. - To receive Alberta School Boards' Reciprocal Insurance Exchange (ASBIE) as information and appoint a trustee to sit on the ASBIE Advisory Board.
- To receive Engagement Session on Promising Practices, Assurance Review and Collective Bargaining as information and recommend all trustees attend.
