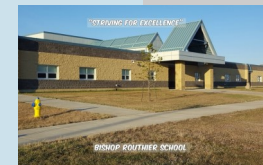

General Questions

1. What is an education program review?

An education program review is a process that looks at a school's programming and operational procedures to determine if objectives are being obtained in an effective and efficient manner, and whether students are achieving defined program standards and outcomes.

2. Why are we having a regional education program review?

Northland School Division created five outcome statements to support student success. In order to meet Outcome Statement One, *Northland students are strong in identity, healthy and successful*, we will be conducting a regional education program review to look at the programming and operations of individual schools in a specific region in order to understand how our schools work alone and could together to support student success.

3. What schools are part of the regional program review?

The schools that are part of the review are in Northland Wards 3 and 4. These schools include: Bishop Routhier School, Gift Lake School, Grouard Northland School, and Hillview School.

4. When is the regional education program review happening?

The regional education program review is scheduled to take place from February 2018 through to May 2018. Specific dates for the review are as follows:

Bishop Routhier School

- April 11-13, 2018—education program review
- April 11, 2018—community engagement
- April 30, 2018—"What We Heard" community share back
- May 1, 2018—"What We Heard" share back with school staff.

Gift Lake School

- May 2-4, 2018—education program review
- May 2, 2018—community engagement
- May 22, 2018—"What We Heard" community share back
- May 23, 2018—"What We Heard" share back with school staff.

Grouard Northland School

- February 5-7, 2018—education program review
- February 7, 2018—community engagement
- February 28, 2018—"What We Heard" community share back
- March 1, 2018—"What We Heard" share back with school staff.

Hillview School

- March 19-20, 2018—education program review
- March 20, 2018—community engagement
- March 28, 2018—"What We Heard" community share back
- March 29, 2018—"What We Heard" share back with school staff.

5. What happens after the regional education program review?

Once the review is complete and the information is shared back with schools and communities, a final report will be written and presented to the Northland Board of Trustees in June 2018. The report will include recommendations specific to each school as to which practices should continue, what other practices should be considered and which practices require improvement.

6. How are parents and community involved in the regional program review?

The review includes an evening community engagement sessions where parents and community members can participate in a conversation about education programming and student success. For parents and community members who cannot attend the event, one-on-one school visits with a review team member can be scheduled through the school principal. Phone interviews can also be arranged.
